Repair & maintenance of civil works of Shaheed Benazir Bhutto University, Shaheed Benazirabad (SBBU-SBA), Sindh invites competent contractors, joint ventures or consortiums to submit sealed Bids / Tenders under SPPRA Rules 2010 and Pakistan Engineering Council guidelines for the following work:

1. Eligibility: The Contractors, Firms, joint ventures or consortiums must have valid registration with Pakistan Engineering Council (PEC) in Category C-6 or above valid registration with Tax Authorities (FBR & SRB).

- i. List of similar assignments undertaken over past 5 years and performance certificate issued by the procuring agency;
- ii. Detail of office, equipment and machineries / transport owned / leased / hired by firm / bidders;
- iii. Bank statement and Income Tax Return of Last 03 years;
- iv. List of litigation (if any) their nature and status / outcomes;
- v. Affidavit that firm has never been black listed.

3. Method of Procurement: Single Stage – Two Envelope Procedure

4. Bidding / Tender Documents:

- iii. **Opening:** Technical Proposal will be opened on same day 02-11-2023 at 11:00a.m in presence of Procurement Committee Members and representative of bidders who wish to attend, whereas the Financial Proposal will be retained with the Tender Opening Committee.
